# Airport Advisory Board

The Airport Advisory Board consists of seven members and meets on an 'as needed' basis. This board provides recommendations to the City Council regarding airport-related business and/or aviation associated with the Ralph M. Hall / Rockwall Municipal Airport. They serve two-year, staggered terms (max. of three, full terms (6 years)).

# Animal Adoption Center / Shelter Advisory Committee

Consisting of five members, the purpose of the Animal Adoption Center / Shelter Advisory Committee is to assist the City with compliance regarding state law pertaining to animal shelters, <u>Texas State Health & Safety Code</u>, <u>Ch. 823.005</u>. This committee is comprised of: one licensed local veterinarian, one municipal official, one representative from an animal welfare organization, and one person whose duties include the daily operation of the city's animal adoption center/shelter. They meet on an 'as needed' basis.

#### Architectural Review Board (ARB)

The ARB consists of seven members who serve two-year, staggered terms (max. of three, full terms (6 years)). The board meets twice monthly - on the 2<sup>nd</sup> and last Tuesday - at 5:00 p.m. at City Hall (just prior to scheduled P&Z Commission meetings). The ARB serves as an advisory board to the Planning and Zoning Commission (P&Z) and Planning Director. Members provide professional recommendations regarding site plans and building elevations submitted within city zoning districts.

# Art Review Team (ART) Commission

The Art Review Team ("ART Commission") consists of seven members and serve two-year terms (max of three terms, or 6 years). It meets the 1<sup>st</sup> Tuesday of each month at 1:00 p.m. at City Hall. This Commission is advisory in nature and exists to:

- (a) promote the Art in Public Places Master Plan;
- (b) develop, evaluate and recommend projects;
- (c) actively explore potential sites for Art in Public Places projects.

# Board of Adjustments (BOA)

The Board of Adjustments (BOA) meets on an "as needed" basis. It is regulatory in nature and was created in accordance with the provisions of <u>V.T.C.A., Local Government Code § 211.008</u>. The BOA consists of five (5) members who serve two-year, staggered terms (max. of three, full terms (6 years)). The City Council appoints four (4) "Alternate Members" to the BOA as well.

# Comprehensive Plan Advisory Committee (CPAC)

This seven-member Committee periodically meets to perform extensive review and make recommendations on revisions to the City's "Our Hometown 2040" Comprehensive Plan. The CPAC works in conjunction with the City's Planning Director, staff and City Council, serving as an integral part in the process of periodically updating the City's Comp Plan.

### Charter Review Commission (CRC)

The Charter Review Commission, will consist of ten citizens of the City of Rockwall who will review how the City government operates under its Charter and determine if any updates are needed. The commission may hold public hearings, examine City records, and may propose changes to ensure compliance with the Charter. After a maximum of six months, the commission will report its findings to the City Council, which may then present any suggested amendments to voters. All applicants must be registered voters of the City of Rockwall.
